It is important that all members should read and be aware of the Rules and Regulations for the League and the Complaints and Disciplinary Policies.

The Codes of Conduct are very important documents which outline expected standards of behaviour in all areas of county/club life, from players to umpires, coaches to spectators.

To All Club Chairpersons

Your continued participation within the SCNA infers that you, in your role as Club Chairperson, are aware of all County Codes of Conduct. You will take reasonable responsibility for the behaviour of the members, associated members and supporters of your club, to ensure that they are upheld. You are agreeing to endeavor to abide by the above codes of conduct and promote them to others.

You understand that if you, as a club, fail to follow the codes, the County Association may take action against you under the Disciplinary Regulations, which may result in sanctions including fines and suspension.

GDPR

Just a bit of a reminder regarding GDPR and our obligations and responsibilities.

Please note that whenever you are collecting personal information from your members, you have an obligation to issue the Privacy Notice to all data subjects at the point of requesting the information. Both the Privacy Notice and Policy can be found on the SCNA Website.

Please make every effort to ensure that personal information is only shared with relevant post holders. Any information from previous seasons that is no longer needed should be deleted and double deleted in order to comply with the GDPR policy guidelines.



If you are emailing information to multiple recipients, please use the 'bcc' option (blind carbon copy). This allows the sender of a message to conceal the person entered in the bcc field from the other recipients.

If you are sending an email communicating personal contact details, then every effort should be taken to ensure that if the information is incorrectly sent to someone who should not be privy to it, that they are not able to open it. This should therefore be sent password protected and the password communicated to the relevant recipients, preferably by another form of communication, but if not then at least in a separate email to show due care. If a third party information is sent in error to an incorrect recipient this should be communicated to our County Data Protection Officer who at present is Michelle Clarke somersetnetballsecretary20@gmail.com
