Performance Treasurer's Report

On behalf of the Committee, please find detailed below a further breakdown of the activities and events Somerset County Netball Association (Performance) have funded in the last year. Coaching

Funding is available for Level 1/2/3 awards which have not been very forthcoming from England Netball this year. EN has recently launched a Level 2 course which funding will be available for candidates willing to coach at Club/Performance Pathway level.

Ongoing funding to support Academy coaches and other County coaches to attend workshops and conferences.

**Junior Academies** 

Supported the running of:

5 Academies @ 5 different indoor venues across Somerset in Yeovil, Taunton and Wellington.

Participation of 136 girls from under 12 to under 15, and support for 18 Academy Coaches for their expertise and travel. Mentoring of beginner coaches has also been funded. Fully funded time and travel expenses for Umpires at the Academy trials/County Tournaments and County Academy matches.

Increase in S & Drovision provided a funded coach for initial testing, ongoing monthly support with online sessions and end of season testing. A report was produced from the professional outfit advising of ongoing considerations and performance level athletes were working to.



A nutrition workshop was fully funded where a nutritionist was brought in to give guidance on eating for performance and general health and wellbeing.

A new kit supplier enabled personalised Somerset kit to be made available at a reasonable cost. All athletes were able to order direct at any time from an online platform.

Future Considerations/Projects

New Academy in Radstock

To encourage development and progression in the North of the County a 6 th hub (Under 13) is being set up to run out of Downside School near Radstock in September 2025. The introduction attracted over 20 girls to apply and it is hoped numbers will increase each year as awareness does. To support the development of this Academy funds have been ring fenced to ensure the opportunity is sustained for girls in the North of the County where travel to Yeovil/Taunton/Wellington to access County training has proved difficult.

**Bursary Applications** 

Access to financial assistance is available and funding is available to ensure access for any hardship cases. Somerset Netball supported 4 individuals this year enabling them to play in the Pathway.

Academy fees will not increase this year as our partners are not putting up their venue hire fees considerably and all other fees in respect of coaching remain unchanged.

## Coaching workshops

X3 workshops are planned in the holidays to offer additional support and sessions to athletes in the Pathway with experienced County/Guest/Bath coaches and in addition to those aspiring to the programme to give them a taster of what they may experience and to work towards. SCNA have sufficient funds ring fenced to offer this free of charge.

Continuation/extension of S & Drovision and Nutritionist

Increase in S & Drovision and guidance and Nutritionist/S & Drovision will be present at the three workshops to give more input and support, where needed. Provision will be more



tailored towards certain age groups i,e. U12 different to U15 and multiple levels as athletes develop.

Coach observations

All County sessions to be open to coaches for observation/CPD purposes to encourage interest in the Pathway and future recruitment of coaches.

Academy kit

The new kit supplier has advised a willingness to carry on with supply of hoodies, t-shirts, training shorts, training vests and training bags with no increase in costs to the athletes.

### Junior Lead – Hollie Wright

I wanted to start by saying thank you to all our Clubs, representatives, players, parents, coaches, umpires and committee members for their assistance this season.

#### 2024/2025 Season

We welcomed Weymouth, Evolution and Weston Super Mare clubs to the junior league this season and we hope that they have enjoyed the season and will continue to be a part of our league.

A huge thank you to Tayna, Jessie, Jan, Sally and Cath for all their help this season and to Clubs for their co-operation especially with our zoom meetings, Google forms and various communications. We will continue our meetings via zoom for future seasons.



We still understand the requirement to progress our juniors and therefore the increasing need for more regular junior games and with the continued assistance of SCNA to help with funding for more coaches and umpires qualified we hope that in the future this is something that can be provided. Often at club level the coaching/umpiring is down to the same people and we would welcome any assistance to help support and improve our local clubs. Please if you have an interest in netball coaching or umpiring contact your club (or SCNA) to point you in the right direction

The improved Strode courts have meant that we haven't needed to rearrange any wet weather dates, and with the use of a secondary venue at Taunton Vale meant we could facilitate more local clubs to TV.

We have revamped our Netball Youth Camps this season working alongside our NDO Jo, meant we could support NYCs and make these cheaper to players. These have been a success this season and we will continue to support this approach for the future.

Thank you to all the umpires this season who have helped out their clubs and other clubs to ensure fixtures were able to be played. Thank you also to Cath Clark for being a liaison with newly qualified umpires when clubs were struggling.

Lastly, we held an End of Season tournament for clubs in May. The winners and runners up of each age group received Netball UK vouchers for their clubs. Well done to U12 Winners - Keinton and RUp - Weymouth, U14 winners - YNC and RUp - TNC and U16 winners - Keinton and RUp - TNC.
