<u>Information on League Format for the season for SCNA Meeting on 27 July 2022</u>

The following rules have been applied:

- COVID amended Rule2.7 allows teams that were withdrawn prior to the beginning of 2021/22 season (so did not enter) -they are permitted to re-enter the Division they were in for the 2020/21 season.
- Rule 4.17 confirms that any team relegated from SW Regional League will be accommodated in Somerset's Premier League.
- There are 49 entries this year and based on the original Rule 2.7 there will be 10 in Premier, 1,2 and 3 and 9 in Division 4. There have been no relegations.

There will be a couple of tournaments on the 10th and 17th September 2022 to ease us back in, but these will not be used to determine divisions, as previously thought.

The 1st matches will be played on 24/9/2022 with at least one central venue per term but moving them around the County. I will be liaising with the local Clubs to sort these out once the dates are known.

In 2019 the KO was discussed and there were plans to look at how we actually run this. I have not had a chance to discuss with the Fixtures Sub-committee, but we will present a suggestion at a meeting early in the season. This will link in with the End of season celebration day.

The rules are in the process of being amended and will be sent out asap. ENGAGE should be in place for September 2022 for recording results etc.

Performance Lead now known as County Player Development Lead (Hazel Davidson)

This will be a transition year for performance pathway and we have already started adapting our programme to run in line with the outcomes required by England netball and the Roses Development framework. Under the framework we will be required to deliver

30 x 2-hour sessions County Academy (U15) sessions

15 x 2-hour Satellite sessions

We will be holding two screening days as trials for both Satellite and County academies in September 2022, we are just waiting confirmation from our venue provider but are likely to be on the 4th and 18th of September at Strode College, letters will be going out t nominated athletes in the next few weeks. Thank you to all school teachers and coaches for supporting the County athlete's nominations with supporting documentation.

England netball have just published a guidance for teachers and coaches nominating athletes to the performance programme. I have attached the link below and hope you will find it useful when considering athletes for nomination in the future.

- i. We want to know what you think. We would like to gage clubs/individuals' views on the way ahead with regards to Saturdays v Evenings, a split league (geographically), central venues etc. We will send out a questionnaire early 2023 to ascertain what is working for you and what isn't.
- **ii**. **Umpire/coaching courses**. We will be charging a £2 county fee this season, but we have plans to use this wisely. The intention is to bolster the numbers of umpires and coaches significantly this season, and that County will pay 50% of all courses to incentivise this. Clubs can further help with costs as they see fit. We also need to have a clearer pathway on development for these officiating staff, and the Officiating lead will



be producing some guidance on this imminently, alongside an Umpires Handbook. Similarly, we have plans to reinvigorate an umpires' forum to help with support and guidance. Coaching is also an area of focus, especially with regards to coaching our youngsters. Action for All Clubs - We need everyone's help with this so please talk to your club members and encourage them to look at the courses that are available. We would be interested to know what is stopping our members pursuing umpiring and coaching too so please let us have your thoughts and feedback on the obstacles to us developing a younger, committed officiating cadre. Are there umpires out there who are not active but interested in coming back.

- **iii**. **Umpiring costs.** There is a great deal of disparity across the County with regards to how much we pay our umpires, if/how we cover travel costs, and timelines for payment. We would like to standardise this so there is greater clarity. This will hopefully help with bringing in new umpires. The payments will escalate with qualification, and we will be making a recommendation re a standard mileage payment of around 35-40p a mile for umpires external to your club. Payment would be cash or bank transfer within 3 days. Can we ask that clubs have a think about any issues they may have with this and let us know. We acknowledge this may be an increased financial burden, but we need to look after our umpires. **Action: Cath to discuss with Officiating Sub-Committee**
- iv. Improved use of the website. Our website has the potential to be much more engaging, but we need you to help with this. We would like to have a feature on all clubs in turn, so every 2 weeks. Some photos and a summary of what you do/when you train/contact details etc would be great. Some of you are already doing this via club social media but we would like to capture this at County level too. Action: Chloe will be in touch about this shortly.
- v. Engaging new players/being more visible. How do we ensure that someone new to the area could find out about us at Club level? Use of the club finder function and thinking about how we engage new players. Importance of belonging New players Action Clubs who in your club is elected to look after and follow up with new members?
- vi. Greater links with schools. Sadly, we often lose our young talented players to other sports in schools, so we will be producing a 2 pager for primary and secondary schools with relevant info on (Primary Bee netball opportunities, basic skills, talent spotting and clubs with junior netball contact details, Secondary guidance on clubs, pathways etc), in the hope that we raise awareness of our sport and hook these



youngsters in at an early stage. Action Jo T and Hollie Alongside this, can we ask clubs to consider if they could possibly open up a juniors' option. Hollie can advise on the set up etc, and it's on us all to create a legacy for the sport.

vii. Celebrating our successes. We are hoping to do more on this via the website and Chloe is doing a great job on social media, but please do send us your stories, even down to celebrating individuals that volunteer at our clubs, players that are shining etc. We will be looking at the Giveback scheme alongside this as a way of recognising and rewarding our unsung heroes. Action Jo and Debs/Julie. Similarly, the Hall of Fame will be established by Dec 22 on the website, and we will look to take in 2-3 new members every year who have made a valuable contribution to our sport. We will call for these nominations in Jan 23.

viii. Central venue days. These are a great thing to do, both socially and for umpire progression/mentoring etc, so we are keen to do more of these. We would like to look at Taunton and Yeovil or Tor. We will plan for the first of these to take place early Nov in Taunton. The committee will be on the case with the planning shortly. Action: Mel has this on her agenda

viiii. End of season Cup/celebration day. This is something the Fixtures Sec is looking at and the aim is to make it fun, giving out medals etc as we used to do.

- Polite reminder to clubs who have not already done so, to confirm Contact list details for their club sent out on the 20th July so that we can get the Contact List sent out for this season.
- Are there going to be fitness tests required for County umpires –This was Introduced in previous seasons for prem and div 1 to ensure umpires are fit for purpose. Action: Cath to discuss with sub-group.
- Are we re-introducing after match refreshments? This will be a decision to be made by individual clubs.



- Clubs to note that if they ask an umpire from outside Somerset County to umpire for them then pre-approval needs to be gained from the Officiating Lead (Cath Clark)
- Action Could clubs ask their umpires/coaches to make sure that their award level is correct on their Engage profile
